- Most current TCCOM Directory is online, Member tab, Park Communications drop down link. I will update it in July. (*Along with a lot of other TCCOM documents.*)
- Empty spaces in Outside Storage are not for guest parking. No cars, trucks or motorcycles are to be parked in outside storage. Guest parking on common grounds is OK.
- Most everyone enjoys a nice campfire. What some members and guests can't tolerate (for health reasons) is smoke. Please -- do not burn wet wood and, as you know per your Rules, there is no burning of leaves, trash, etc.
- New signage at the Construction dumpster and Scrap Metal and Electronics trailers with prices for disposal of typical items.
- No leaves, garden refuse or branches in household dumpsters. Please deposit in the respective leaf pile or burn pile.
- Off Season Bulk Emails are posted on Office Bulletin Board. If you haven't been receiving these emails, please:
 1. Check you Spam folder. Email providers often change their security protocols and, as a result, emails you used to get now go to the Spam folder.
 2. Ensure the Office has your current email address.

3. Let the Office know you aren't getting the bulk emails if you didn't find them in your Spam folder and we have your correct email address.
- Because of our septic system, please use liquid, not powder laundry detergent in the washing machines.

Maintenance Manager's Report – 2017 Annual Shareholder's Meeting

Welcome back to TCCOM. Glad to see everyone.

First off I'd like to thank our President and Directors for all their efforts in dealing with the challenging issues that arise here at the Park. Also I'd like to thank all the Committee members and individuals that spend countless hours giving back to our community.

Last fall TCCOM received a letter from Sherburne County informing us of a new compliance mandate for our septic systems. This new mandate requires us to have all twenty two of our septic systems pass a compliance inspection prior to any new building permits being issued. We started that process last fall and after completing the inspections, we have one system that did not pass. The septic system contractor is now in the process of designing a replacement system that will meet the new compliance standards and the project will commence as soon as the design is approved by the County Officials. It's too early to predict a date of completion and as soon as we find out, I will notify the office. After speaking with the contractor regularly for the past few months, they thought it might be done as soon as the beginning part of July. We will post a notice at the clubhouse when this project is complete. We are sorry for any inconvenience this may have caused you. However, we were not given any advance notification from the County.

Mosquito season is here and an article describing the Park's mosquito spraying protocol is posted at the clubhouse. Based on the Minnesota Department of Agriculture regulations, we must follow their guidelines as to when and how often we can spray.

The golf course is looking great this year thanks to all the hired help and volunteers who spend countless hours to maintain and make it as nice as it is. The golf committee continues to meet and discuss ways to improve our course. Thanks to all of you! **Just a couple of reminders...** It's a Park rule to start your golf game at the 1st tee. It is the golfer's responsibility to replace or fill your divots, repair your ball marks and pick up your broken tees. Please remind your guests. As it stands, the rule for the use of a tee is not mandated. The reason I mention this is that I've had many comments on this topic.

The added portion of the 4th tee box will be opened up as soon as the grass is ready for play. Also I would like to express my concern pertaining to golf etiquette, particularly as it involves golf course employees. When a maintenance member is on the tee box, fairway or green, we will try our best to finish our job or "section of mowing" etc., as quickly as possible. We, as much as anyone, realize the importance of keeping the "speed of play" as fast as possible, as to not keep anyone waiting. **Please do not tee off at any golfer or maintenance worker!**

The leaf clean up that is being done by Clean Cut Lawn Care is proving to be a great success with extremely few problems considering the monumental task at hand. The vendor has promised to report any possible property damage directly to me so I can notify members personally. I met with them last fall and they have a suggestion for the members and that would be to use larger and heavier landscape rock rather than light materials like wood chips or lava rock for their landscaping needs. They explained to me that they try very hard not to blow away or mess-up the landscaped areas on member lots but, with the larger blowers they use, it is not possible to clean up all the leaves without disturbing the lighter landscape materials. Their recommendation is to use materials such as buff limestone, brine rock, granite, larger river rock, rip-rap or... solid gold depending on your budget. Stay away from things like pea gravel wood chips or shredded wood.

The Minnesota Department of Health was here this spring for our annual well water inspection. We passed all test results with no problems. The final report is posted in the Clubhouse.

The pool is open and functioning very well. We passed our annual Minnesota Department of Health inspection with flying colors. In fact we were commended on how neat, clean and well taken care of not only our pool is but, **the entire Park.** Again, many thanks to all who are involved with these efforts. We are looking for volunteers to close the pool in the evening at dusk. We have scheduled it in one week intervals from Tuesday thru Monday. Please stop by the office to sign up. And lastly, in case you haven't noticed, there is a new added patio outside the pool. Because food is not allowed in the swimming area, we've added a picnic table to this area. Also we have placed the bike rack in there.

The Maintenance department is in the process of a tree injection program that includes Ash trees for the prevention of Emerald Ash Borers and Oak trees for Burr Oak Blight. We are treating select trees around the park (some marked with orange tape) in areas including the golf course, common ground and on residential lots.

Thank you all and have an enjoyable season.

Burn Pile Notes

Who doesn't enjoy watching a controlled burn? Dale and Ted put on a great show on June 1st when they burned the Burn Pile, located just north of Lot #442.

However, the operative word is controlled. We've noticed some members dumping ashes in the burn pile (versus a minimum of 3 feet from the burn pile) and in the woods. Both of which can ignite unexpectedly no matter how much you believe the ashes are out.

Also, some members are dumping contaminated dirt (dirt with gravel or sod) by (or in) the Burn Pile. Clean fill dirt can be deposited on the west side of the road to the Burn Pile. Contaminated dirt must be removed from the Park.

And finally, the Burn Pile is for branches only per the sign. The DNR does not allow us (or anyone at their residence) to burn treated, painted, glued, etc. lumber (that goes in the construction dumpster and is paid for at the office), trash (goes in respective dumpster) or leaves (goes in temporary leaf pile).




Did You Know?

TCCOM was originally incorporated in 1977 by John Olson, Harry Osvold, and Dan Person; 299 lot sites were laid out the following year, and were completely sold out by October 1979. The annual fee was \$190 a year and included electricity and taxes. At the general membership meeting on May 3, 1980, the first board of directors was installed and ownership was transferred to the members. Notes from the history of the park indicate 273 bottles of champagne were consumed at the celebratory luncheon following the meeting!
